## Learning in a Digital World During a Pandemic

Friday, March 13 was the last day of face to face instruction for schools in our area due to the COVID-19 closure of schools across the state. While a daunting task, Madison Consolidated Schools acted swiftly to implement a detailed district-wide alternative education plan focused around their existing eLearning platform.

### Preparedness

MCS has had eLearning in place for over six years. When first introduced in 2011-2012, eLearning in our community was a very new concept. MCS had a vision, a progressive approach, and made a large investment in technology creating a 1:1 environment where each student had a device. Board minutes indicate that in 2012 iPads were approved for an elementary classroom pilot program while there were already six eLearning days for secondary students scheduled for the 2012-2013 school year. "The leadership of this district dating back to 2010-2011, prepared us well for what was to come," shared Dr. Jeff Studebaker, Superintendent. "The early adaptive work to technology in education set us apart during the recent pandemic."

By 2013, the district was utilizing six scheduled eLearning days at the high school level where students worked from home remotely. Elementary students used these days to learn about and practice 'remote' learning tools from the safe confines of their classroom guided by their teachers.

Fast-forward only a few years and the district was one of the first approved by the state to utilize eLearning days to make up inclement weather days. Each year the district has improved upon adaptation of curriculum, delivery, devices, and tools available in order to enhance the digital learning experience. "Students today, as well as many adults, are very comfortable with a vast number of devices, platforms, and delivery mechanisms when it comes to content consumption," Studebaker continued. "Our world, our workplaces, our homes are all much smaller and more connected thanks to evolving technology that is available at our fingertips."

**March 2020**  
When COVID-19 closed our traditional school environment, MCS was well-positioned to take eLearning to the next level. "Our students and teachers were well prepared for digital learning," continued Studebaker. "What we were not completely comfortable with was how the systems and processes we used for (what had been) short-term periods of use would hold up over the long haul and what that

would need to look like compared to what we had been delivering. eLearning and the tools associated with it were never intended to replace face-to-face instruction within our district. However, after working to structure long-term, engaging learning environments during the recent shelter-in-place, we see both a need and value for a more robust, virtual aspect to our overall approach to education."

### What we learned...

"Our district leadership met regularly [virtually] to discuss details of the learning environment as it was unfolding," shared Studebaker. "We knew our staff and students were engaging at some level in various aspects of learning, but realized quickly there was room for improvement." Across the district, teachers used Google Meet, Zoom, or other platforms to gather their classes. It could have been daily, weekly, or less structured but that face-to-face interaction proved

invaluable for teachers and students. At all grade levels, students were encouraged to get active, use household items for projects, and use their phones

to capture images and email assignments, if connectivity was a challenge. "The majority of our staff went above and beyond to help facilitate success for students," shared Studebaker.

### ThoughtExchange



In an effort to better understand what worked well, identify barriers, and capture frustrations, a ThoughtExchange was launched inviting parents/guardians, staff, and students in grades 5 - 12 to share their experiences. "We had some very thoughtful responses, shared Ashley Schutte, Communication Coordinator. "It confirmed some of the things we thought were happening, identified areas for our next steps, and will help prioritize our

work moving forward."

Top thoughts were themed into five broad categories: Preparedness and Social Emotional Supports, Motivation and Accountability, Classroom Environment, Communication, and Training Opportunities. "We took the top-rated thoughts received (178 of 748 total) and placed them in broad categories for organizational purposes," shared Schutte. "We invite everyone to visit the results sites from the link on our homepage (madison.k12.in.us) where they can read all thoughts that were shared. Our goal in creating the themes was to help our families begin to dig into the data, as well as, help prioritize our work."

MCS was much better positioned than a number of schools within the region to launch a digital initiative. "We knew going in that it would not be our preferred method of instruction, but looking at some other districts in our area and around the state that did not have the technology or experience with remote learning, we knew our staff and students would persevere," shared Studebaker. Overall feedback results were positive and confirmed the district was well prepared. However, the survey also revealed and confirmed areas of opportunity for improvement moving forward. "The feedback from all participants regarding a desire for

## From the Superintendent's Desk

# A Virtual Success

Since the last issue of the District Correspondent, we have experienced an unprecedented shelter in place order that changed many aspects of our lives. It is frequently said that crisis situations uncover the strengths and weaknesses of people, communities, and systems (government and business models). This crisis certainly has done exactly that. We are very fortunate to live in a community where most people care about and take care of each other, educational systems are strong, flexible, and resilient, and governmental agencies are able to work with everyone for the benefit of everyone. Here are some of the many ways the Madison Consolidated Schools was able to help our students and families while we were unable to be together in our buildings:

The teachers in the district ramped up and in many cases got even better at delivering their eLearning courses for their students. The elementary school students completed over 80% of its digital assignments over the course of the shelter in place months! And teachers found ways to reach individual students and meet nearly every students' needs.

Our Food Service team served over 36,000 breakfast and lunch meals to students while we were locked down!

Our Transportation Department placed and rotated seven buses at strategic places around the community to help deliver WIFI signal to some of our families in more rural areas.

Several parents and community members helped our

students stay active and fit by providing places for them to safely work out once safe.

Our Technology Department was available to assist teachers maintain and enhance their delivery and techniques within the digital learning environment. They also conducted Curbside Tech help that served on average 9 students per day at each location in order to help them keep their devices running over the shelter in place period.

While the spring of 2020 lost all of its sporting events and traditional school events, we will be able to do at least a few items to celebrate our students and their accomplishments.

As we begin our reopening processes, several activities will occur and various programs will restart. The Athletic Department has put together its reopening documents that will guide how our athletes will begin practicing and competing again. In addition, the high school has rescheduled its production of Newsies in the newly renovated auditorium in July and has a full Commencement planned for our gradu-

ating Seniors in July as well. Our 4th grade students will also have an opportunity to say goodbye to their elementary school and also have an opportunity to be introduced to their new 5th grade building at some point in July.

As of this writing, the district's reopening plans are nearing completion and they will be shared, discussed, tweaked, and approved by multiple agencies over the coming days and will be released as soon as possible so that everyone can plan for the fall. Our emphasis on our reopening is on the safety of all of our students, employees, and families. We will base our decisions on science and practicality as we work closely with Indiana's education and health officials as we move toward a safe and exciting reopening this fall.

It truly is an exciting time to be a part of Madison Consolidated Schools! We are improving, innovating, and growing! We are excited to have many new students and staff members joining us for our next school year! We have numerous facility upgrades in progress that will dramatically improve the fiscal outlook of the district as well as the experiences given to our students. 

more face-to-face interaction, more structured days with log-in expectations, and more accountability were all things we were discussing not only as district leaders, educators, and administrators, but

also as parents of students in the district," continued Schutte. "Our entire team is very excited about the opportunities we have in front of us to make our virtual learning experience engaging for students, as well as user-friendly and accessible for parents."

# An Unprecedented Year for the Custer Contest

On April 16, 2020, the 109th Annual Custer Oratorical Contest joined the ever-growing COVID-19 pandemic closure cancellation list. Originally scheduled for Sunday, April 26th, the traditional, public performance was shifted to an optional, submitted video recording of the student's recitation. "While there are a number of things that were canceled due to the pandemic, this is a very unique event and a community favorite," shares Michael Gasaway, MCHS Principal. "As with all things, we are very sorry to see this as the students have been working hard to prepare their pieces".

Each year a Custer Contest invitation is extended to the top five MCHS seniors who have the highest, weighted grade point average, meet the attendance requirement criteria, and have completed all four high school years (8 semesters) at Madison Consolidated High School. If any of the top five seniors decline, the invitation is extended to the student with the next highest GPA, again, utilizing the same criteria as a tie-breaker, should it be necessary. "This year, we were looking forward to having six participants due to identical GPAs for the two students in the 5th position, and all had accepted the invitation to participate," stated Gasaway.

Each student is given the contest guidelines at the time of their acceptance of

the invitation to participate which is usually around the beginning of February. The funding and original guidelines were established by Mr. A. S. Custer in 1911 and were based on the model of an oratorical contest that has been held at Wabash College since 1875. In part, the student's oral selection must be an original oration or selection of literature, can be edited, and must be approved by the student's Custer coach. Each presentation is required to be 12 minutes long at a minimum and no longer than 15 minutes when presented. Each piece should be oratorical in nature, without extensive theatrical acting, no props are allowed, and penalties are assessed for being over or under the time limit. Over the years guidelines have adapted to a degree. Today the judges are anonymous, enjoy the recitations for the first time just as other audience members, and base each presentation against a standardized rubric to determine scores and overall placement.

I reached out to the six students and their coaches and asked them to share their experience in what was a very non-traditional year for Custer. Krista Lee, an MCHS teacher, and 2008 Custer Contest winner shared "Custer was such an important event in my life! I worked so, so, so hard on my piece that I could still recall most of it today. This year the circumstances are so different I don't know if the piece will become a part of the student in the way it has

for others. It is still such an accomplishment to be asked and something that sets the top students apart, even from top seniors at other high schools."

The selection of the literary piece is a huge component of the process. Jill Koren, coach to Bailey Hankins and Isaac Boone, shared "one of the things I find most valuable about the Custer contest is the rich discussion of literature that occurs. As a teacher of literature, I can especially appreciate the in-depth thought process required of a student who must imagine embodying a piece of literature, including all of the characters and convey their original interpretation to a live audience." Jessie Dyer shared "The process of choosing my piece took a while. I wanted a story that was powerful and represented a strong female lead who was able to overcome struggle. I had about six books that I was trying to decide between, but my coach and I both decided *Where the Heart Is* by Billie Letts was the story we wanted to share."

Participants and coaches alike agree that the work and preparation that had taken place up to the time the cancellation was announced were outstanding and no one regretted the opportunity to be a part of the Custer legacy. "... it was an awesome experience and I learned so much," shared Elias Hanson. Dyer continued, "Even though I was really nervous and taking on this challenge was outside of my comfort zone, I was looking forward to present-

ing my piece."

Part of what makes Custer so engaging for the audience and challenging for the student is the live nature of the presentation. In preparing for this story, I have learned a lot about what it means to select a literary piece, the time and attention to detail that is needed to bring the story and characters to life, and deliver with a passion...all while being mindful of the time constraints present. Will it speak to the judges? Can I convey what I see in my mind through an adaptation on stage? All of this combined with both the thrill and fear, of being in front of a live audience is something you cannot replace with a video camera in your home. While none of the students opted to record their performance, Jessie and Elias shared their thoughts on what turned out to be their only disappointment in the overall experience. "I didn't submit a video because the entire process became more difficult with the social distancing aspect. I no longer could meet with my coach face to face and the video conference made it hard to do what we wanted to get done." Amanda Harsin, Dyer's coach, shared the regret of not having a live audience. "I was so proud of how much Jessie worked on selecting a piece, crafting the excerpt, and mastering the content. It made me very sad to not be able to see her deliver it in front of a big crowd the way she deserved!" While it may seem simple enough to record a video, there are

a number of things that added an additional level of stress to the process. Dyer continued sharing "I was practicing for hours to get my piece how I wanted and then I was becoming really stressed about how to record and what actions would fit in the video screen. All of these inconveniences pushed me to decide it was not in my best interest to submit via video." Fellow participant Elias Hanson concurred, "I didn't submit a video because even though I had memorized my piece it still would have required many hours of additional work. Not being able to perform for a live audience made it hard to stay excited about it. To me, it can't be Custer unless it's live."

Koren shared that Isaac Boone had selected *The Adventures of Tom Sawyer*, partly because it was a classic he wanted to explore. He ended up reading as a book of choice with his AP Literature book club and presenting his interpretations to the combined AP Literature sections (roughly 40 students) in a lively Zoom meeting, "so all was not lost!" expressed Koren. She went on to talk about selection, "it's not always the 'favorite novel' though a passionate love for a particular piece goes a long way. There is the consideration of audience appeal and pace, dialogue versus description, tone, dialect, humor, drama...basically everything that makes great literature great!"

Tracking all of the separate assignments was a challenge, Leslie ended up with a dry-erase board for due dates, online class, video chats, etc. "so we all had a visual and my kids owned/shared the responsibility to manage things." Her sophomore, who is enrolled in AP and dual credit courses, only slipped

once due to time management - "but it turned into a valuable lesson."

Keeping everyone focused on their work when she couldn't be right there with them the entire time was difficult. There is so much to do at home (toys, snacks, pets, farm animals, more snacks!) that doing homework for the day wasn't high on the list of their 'things I want to do today'. Overall, she noted, teachers

really seemed to be understanding of the situation and were not more overwhelming than necessary and as a whole the workload was not unreasonable or unmanageable.

There were tech issues on occasion - assignments didn't submit, or a camera quit working, "but there was no human fault in that." As a result, she has realized she needs to know more about technology.

"I felt very supported and that was huge for me! Not only through the teachers, but the principals, staff and tech team all really stepped up to make sure we got taken care of!"

If she could change one thing...it would be the live video time. "I really wish they had more of it. I have no doubt that if the teachers could do daily video chats to teach what they are working on it would

help tremendously with not only comprehension, but with motivation and overall morale."

# Athletics Reopening Guidelines will be First Test

Even though spring sports were canceled, coaches kept in touch with athletes encouraging healthy activities and providing workouts athletes could do at home. While Physical Education was part of the overall eLearning experience for students, physical activity was highly encouraged during most family and student interactions. Not only for its benefits on the ability to focus but overall mental health. High school strength and conditioning coach, Jay Roney, kept up with his students via videos they submitted of their assignments/workouts and an app called Train Heroic. “Now with school out for summer, our hope is our fall coaches can assist as one more point of contact to keep kids active,” shares Joe Bronkella, Athletic Director. “Not only is exercise good for them, it is very important for our student-athletes to keep in shape so we can shorten the cycle of conditioning as our teams prepare and hope to report on time for the fall season workouts.”

## Preparations underway:

Fall athletics information was emailed to high school families in early May. “We saw this as an opportunity to gauge interest in upcoming sports, connect students with coaches, and keep in touch with families over the summer,” shares Bronkella. “We will be doing a similar information blast for junior high fall sports as time gets closer.” Most Junior high athlet-

ics do not begin until school starts and do not typically have specific summer workout programs. Junior high athletes are encouraged to contact the high school coach for their sport if they would like to participate in pre-season conditioning programs.

## Some things to note:

Per the State, all Madison facilities remain CLOSED until June 30, 2020. This means no team, coach, or athlete can be on any campus, field, court, or playing surface participating in any school organized activity. If, and when, we receive additional updates we will pass those along.

The IHSAA released information regarding the annual sports physical requirement.

If a student participated in a sport and had a valid physical on file for the 2019-2020 school year, they will not be required to have a new sports physical for the 2020-2021 school year.

If a student transfers into Madison from another, they must present a copy of their valid 2019-2020 sports physical to their coach prior to the first practice date.

If a student is new to our school and/or did not participate in athletics last year, a sports physical will be required before they can participate.

er swap outs so students could complete their work,” shared Alex Hobson, Educational Technology Coordinator for the district. There were twelve events and each location averaged nine students served per day.

## Re-Opening in Phases:

Per state guidance, athletics will be the first opportunity for schools across the state to test the waters in the new world of post-COVID-19 guidelines for interaction. “We have had a district team working on reopening plans,” shared Bronkella. “I have worked with other AD’s in our

region as the IH-SAA, Governor, and IDOE have been working toward allowing us to gather. Using these guidelines, our district team has worked together to incorporate the learning and been able to expand these processes into what will soon be our larger, detailed, district-wide plan for bringing students safely back to school.”

Athletics, co-curricular, and extra-curricular activities will return in three phases. Below is a high level summary of each phase. The detailed plan will be shared with parents/guardians, student-athletes, and coaches by the end of the month and will also be available to view on our website.

## Phase 1: July 6 - July 19

All summer activities are voluntary. Activities will have time and day restrictions where hygiene and social distancing standards are followed to the extent

possible. Locker rooms and weight rooms will not be used and no formal competitions will be allowed.

## Phase 2: July 20 - August 14

Locker rooms and meeting rooms are available for use at a recommended 50% capacity. Contact is permitted per the IHSAA guidelines but no formal competitions are allowed with the exception of girls’ golf with only essential personnel, there will be no spectators or fans allowed.

## Phase 3: August 15 and forward

Competitions may begin with spectators, media, and vendors in attendance. Stipulations include all attendees follow social distancing guidelines, safety protocols, and follow established mass gathering guidelines.

Madison will continue to monitor and follow all guidelines set forth by our state government. Updates will be pushed out on social media feeds and the district website. “One of the highlights of this experience was the way our staff circled the wagons to meet the needs of our families,” stated Studebaker. Meal pick up service was offered at buildings and gave principals and counselors the opportunity to be available to families should they need them. Breakfast and lunch meals were available for pick up through a reservation system, two days a week with mid-day and early evening curbside shifts to accommodate family schedules. “Our staff prepared and served a hot meal on Mondays and Wednesdays and sent sack lunches home for Tuesday, Thursday, and Friday,” shared Judy Brooks, Food Services Coordinator. “Our food service team provided 18,254 breakfasts and 18,254 lunches for our students while they were learning from home.”

Curbside Tech Support events took place throughout the county and were very well received. “Our tech team set up shop outside at Rykers’ Ridge Elementary, Deputy Elementary, and MJHS to offer assistance to students ranging from chargers and password resets to screen replacement and loan-
