Coach Schutte gave an overview of this past swim season: "Good evening President Yancey, Dr. Studebaker, and board members...thank you for inviting us this evening.

I would like to invite forward our Sectional Champion and State Qualifying Medley Relay Team.

These four young men represent the Madison swim program this evening as the first State Qualifiers since 1986. Swimming works a bit differently than other sports when it comes to state qualifying. A swimmer must have two personal best, back-to-back performances culminating in a Sectional Championship in their event in order to move forward. There is no second chance through a Regional portal - it is straight to state. Once the champions have been placed, there are a few remaining positions where a swimmer may advance with the next highest state qualifying time but it is very competitive and hard to do.

We knew we had something special this year...these young men are part of a very strong team which compiled a season record of 8 - 4 overall in our last year as part of the very competitive HHC.

They played a large part in the 4th place HHC conference meet finish where we amassed 12 HHC Honorable Mentions.

Their team placed 3rd in the Sectional meet where they achieved:

- 19 Personal Best Times
- 4 school records
- Top 8 placement in every event
- 4 Sectional Champions and the first State Qualifiers since 1986

This is our Sectional Champion and State Qualifying Medley Relay Team of Carter Schutte (backstroke), Justin Banks (breaststroke), Liam Roney (butterfly) & Jack Kelsey (freestyle).

They finished 30th overall in the state with a time of 1:41.14, a time just short of their season best and new school record time of 1:40.09.

Individually:

Justin Banks is the Sectional Champion and State Qualifier in both the 200 IM and 100 Breaststroke events. Justin finished 26th overall in the state in the 200 IM with a time of 2:00.27 and 27th overall in the 100 Breast with a time of 1:00.19. He now holds the school record in the 200 IM at 1:57.17 and the 100 Breast at 58.55 - both previously set in 1986 by Tom Solomon.

Carter Schutte is the Sectional Champion and State Qualifier in the 100 Backstroke and tied for 28th overall in the state with a time of 55.13, which is a personal best time and new school record which was previously set by Ben Canida in 1997.

Liam just missed a guaranteed state berth in the 200 Free with a photo-finish, 2nd place sectional finish with a time of 1:46.72 - a personal best and new school record in the event.

These results are not accidental. These young men have been swimming together since they were all very young, around 7-8 years old. It is the culmination of years of hard work and a desire to be the best they can be. We have been very focused and intentional with the philosophy and alignment of our feeder system, H2O Swim Club, which you so graciously allow to flourish through use of our incredible facility. I would like to thank the club coaches (John Schutte, Melanie Banks, and Ben Canida) and the H2O board (Melanie Banks, Jamie Kelsey, Melissa Wynn

and Bobbi Klein) for their commitment to excellence and development. It is through their tireless efforts that we are in the position we are today with our junior high and high school programs and the growing success we see.
