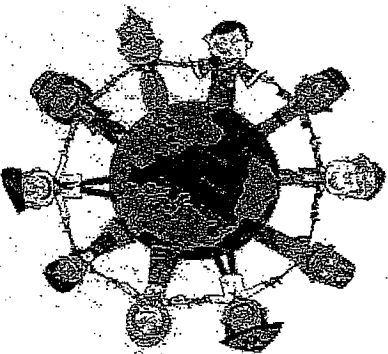

Child Care Voucher Program

What is the Child Care Voucher Program?

The Child Care Voucher Program is funded by the Child Care Development Fund (CCDF).

The fund is administered by the State of Indiana and operated by River Valley Resources, Inc.

The Child Care Voucher Program assists eligible families with up to 100% of their child care expenses*.

Eligible participants must:

- Be currently working or attending school
- Meet certain qualifications, including income guidelines

* Depending on your family income, a co-payment may be assessed.

Income Eligibility

River Valley Resources will determine your eligibility for the Child Care Voucher Program based on your gross monthly income.

Eligibility typically lasts for six months and then participants are required to re-certify for the program.

Income Guidelines

Your gross monthly income, including child support payments, must be at or below:

Family Size	Gross Monthly Income
2	\$1686.00
3	\$2126.00
4	\$2566.00
5	\$3007.00
6	\$3447.00
7	\$3887.00
8	\$4328.00
9	\$4768.00
10	\$5208.00

These rates are effective 5/18/2015 and are based on CCDF Federal Guides Lines.

What do you need to apply?

Proof of your gross monthly income for the last 30 days.

River Valley Resources can verify your income by reviewing pay stubs or award letters.

If you are starting a new job, a written statement from your employer.

This statement should be on company letterhead and include your date of employment, hours/days per week and your rate of pay. This statement must be signed by your employer.

If you are enrolled in school/training, proof of enrollment.

River Valley Resources can confirm you are enrolled in school/training by reviewing a current confirmed class schedule or a letter from the school, on the school letterhead, that states your days and hours of attendance.
