He said we would reuse materials that are available.

History cannot be changed but can be learned from. Needless to say, the problems still exist and it is imperative they be dealt with. There are many root causes of which I will name a few: age of facilities, poor initial design, change of needs over the decades, change of state and federal mandates and codes, and yes, a lack of proper maintenance in some areas. Band-aids and emergency repairs have consumed and will continue to consume virtually all of our available capital project funds which should be used for general maintenance, preventative maintenance, and some minor upgrades. This trend will continue to accelerate as the problems continue to get worse.

I want to make it perfectly clear that what I am saying is coming from me and that I am speaking for myself and not for the rest of the school board. They may choose to agree or disagree.

At this time, I am reaching out to the school district community to step forward, become involved, educate yourself about the situation, put history and grudges behind us, be respectful to one another, and become part of the solution to this problem. It will require a lot of time and energy but it will be worth the effort. There are many brilliant

minds in this community and I challenge you to put them to work and come up with a plan we can all support. I am willing. Are you? This is urgency whether you believe it or not. Now is the time to get started."

Mrs. L. Imel said she agreed with Mr. Glesing. She said there were more people in the audience tonight than the past six months. She asked the audience to help fix the problems. Mrs. L. Imel said the "vote no" wasn't for the right reasons. She said there are bitter people in the community. Mrs. L. Imel said it is time to start over and for the community to step forward.

Mrs. L. Imel asked Dr. Studebaker-Bolinger to explain a two million dollar bond issue. Dr. Studebaker-Bolinger explained a two million dollar bond must be used for that specific building. She said it is illegal to ask for bonds for specific schools and then use them at another.

Mrs. J. Imel said she appreciates those who have served the students of Madison Consolidated Schools. She expressed thanks for all they have done. Mrs. J. Imel said we are losing solid teachers and they will be missed.

Mrs. J. Imel said she thought the referendum would pass. She said it was a blow. Mrs. J. Imel said the most hurtful comments made were regarding "putting children first". She said she worked for Madison Consolidated Schools for 40 years and there was never a time it wasn't always about the children. Mrs. J. Imel said everything in the

referendum was for the children. She said she was extremely disappointed the referendum didn't pass. She said something must be done for the safety of the children and staff. Mrs. J. Imel said the task force worked diligently.

Mrs. L. laCour said she attended the Super Bowl competition at Austin. She said our scores were out of this world.

Mrs. L. laCour said she witnessed the building trades class working as a unit building a gazebo. She said they will graduate with skills.

Mrs. L. laCour said we educate our students to the best of our ability and said do not knock our kids!

Mr. Bass said the board isn't here to create animosity. He said it is a fact our buildings are falling apart. He said students attend school in buildings they shouldn't be in. Mr. Bass said we would continue band aiding the issues. Mr. Bass said referendums rarely pass the first time. He said he knew it was an uphill battle. Mr. Bass said what he didn't expect was the negativities, untruths, and misrepresented figures. He said it is hard to compete against that. Mr. Bass said no one attended the April board meeting. Mr. Bass said all need to be on the same page. Mr. Bass thanked the task force who were volunteers. He said they were a cross section of citizens. Mr. Bass said from day one the task force meetings were open to the public. He said everyone was invited to attend. He said zero community members attended the meetings. He asked why is it after the fact that some want to be involved. Mr. Bass said the problems aren't going away and asked the community for support. He said the board needs ideas on why the referendum failed. Mr. Bass said the negativity has to stop. He said we all need to be on the same page. Mr. Bass invited the audience to attend the board meetings.
