APPROVAL TO DECLARE CAFETERIA EQUIPMENT OBSOLETE AND OF NO FURTHER USE TO THE CORPORATION

Upon the recommendation of Dr. Brown and a motion by Mrs. Yancey, seconded by Mr. Roney, the Board voted, 4-0, and the motion carried to declare the following cafeteria equipment obsolete and of no further use to the Corporation:

The value of the milk cooler and washing machines does not exceed the cost of repairs, and the Hobart oven is being replaced by a more efficient model.

Upon the recommendation of Dr. Brown and a motion by Mrs. Yancey, seconded by Mr. Roney, the Board voted, 4-0, and the motion carried to approve the curriculum addition to Madison Consolidated Schools Grades Kindergarten-12th grade.

This program will meet the requirements of Senate Enrolled Act 355-Child Abuse Education and Policies (IC 5-2-12.1-12; IC 20-19-11; IC 20-26-5-35.5; IC 20-30-5-5.7) Senate Enrolled Act 447-Child Services (IC 20-28-3-4.5) This requires all K-12 schools-public, private, and charter- to offer instruction on child abuse and child sexual abuse.

MBF Child Safety Matters is a comprehensive, evidence-based prevention education program for elementary school students in grades K-5. The program teaches students and adults how to prevent, recognize, and respond appropriately to the four types of child abuse (physical, emotional, sexual, and neglect), bullying, cyberbullying, and digital dangers.

MBF Teen Safety Matters is a comprehensive, evidence-informed prevention education program for middle school students in grades 6-8 and high school students in grades 9-12. The program addresses emotional, physical, and digital safety, and teaches students and adults how to prevent, recognize, and respond appropriately to the four types of child abuse (physical, emotional, sexual, neglect), exploitation/trafficking, sexual assault, and relationship abuse.

The Children's Advocacy Center of Southeastern Indiana has provided Child Safety Matters Prevention Programming to nearly 9,000 students since starting the program in 2020.

The Children's Advocacy Center of Southeastern Indiana utilizes a multidisciplinary approach to investigate reported crimes against children.

APPROVAL TO PURCHASE VEHICLE

Upon the recommendation of Dr. Brown and a motion by Mr. Wallace, seconded by Mrs. Yancey, the Board voted, 4-0, and the motion carried to approve the purchase of a 2023 Chevrolet Equinox from Chandler Chevrolet in the amount of \$30,385.25.

APPROVAL TO INCREASE SECOND MEAL PURCHASES

Upon the recommendation of Dr. Brown and a motion by Mrs. Yancey, seconded by Mr. Roney, the Board voted, 4-0, and the motion carried to approve the increase of second meal purchases to \$4.60 for additional lunches and \$2.70 for additional breakfasts in both the elementary and secondary cafeterias.

Per the regulations of the National School Lunch and Breakfast Program, all students are allowed one reimbursable lunch and one reimbursable breakfast each day.

A reimbursable meal is one where all the necessary components in the proper amount is served.

The Food Service program receives different amounts of reimbursement depending on whether the student is considered paid, reduced, or free.

If a student wants to purchase an additional meal, it is NOT reimbursable, and the meal is considered ala carte. We have traditionally charged the paid meal price for extra meals.

Recently the State Agency has informed all schools in Indiana that the payment for additional, non-reimbursable meals must be sufficient to cover the overall cost of the meal, including the value of any USDA entitlement and donated commodities used to prepare the meal. In other words, we cannot use federal reimbursement to cover the cost of non-reimbursable meals. The same is true for adult meals and ala carte items.

Therefore, we are required to raise our 2^{nd} meal prices to \$4.60 for additional lunches and \$2.70 for additional breakfasts in both the elementary and secondary cafeterias.

This change will not affect many of our students, as very few of them occasionally wish to purchase a second meal. This mainly occurs at the High School.
